<b>Professional Member:</b>	Managers, administrators or assistants of a city, village, township, county, or council of government. Membership entitlements include voting privileges and access to the listserv. Member rates for all MME events.
	Annual Dues                      \$110.00
<b>Affiliate Member:</b>	Local government professional with division or department head responsibilities. Not eligible for access to the listserv.
	Annual Dues                      \$110.00
<b>Consultant Member:</b>	Members of consulting firms specializing in local government. Eligible for discounted rate (from the nonmember rate) to the Winter Institute and the Summer Workshop. Not eligible for access to the listserv.
	Annual Dues                      \$250.00
<b>Retired Member:</b>	Professional members who are no longer employed on a full time basis. Membership entitlements include voting privileges and access to the listserv. Complimentary registration for the Winter Institute and the Summer Workshop.
	Annual Dues                      Complimentary
<b>Manager in Transition:</b>	Professional members who are currently in between jobs and actively seeking a manager position with a municipality. Membership entitlements include voting privileges and access to the listserv. Complimentary registration for the Winter Institute and the Summer Workshop.
	Annual Dues                      Complimentary
<b>Emerging Leader:</b>	Enrolled college student and/or current municipal intern. Complimentary registration for the Winter Institute and the Summer Workshop. Access to the listserv through a municipal email only.
